PROCESS & FORMAT

Theme: Collaboration in Human Ecology: Interdisciplinary, Integrative, International.

Immediate Objectives: Develop a consensus on the current status of human ecology, establish common aims for human ecologists to work toward, and agree upon specific recommendations and steps toward more fully interdisciplinary, international collaboration.

Long-term Objective: Lay groundwork for making human ecology more accessible and useful to policymakers and practitioners.

Innovative Format: This conference will break from the traditional "stand-up paper presentation" format. A highly participatory process will involve all those attending in an alternating series of small-group workshops and plenary sessions. The process will be professionally facilitated. To maximize the benefits of working in small groups, conference attendance will be limited to 150. (Thirty of these slots have been set aside for student interns, recorders, and participants.)

Three-Part Process: In keeping with our immediate objectives, the conference will address three central questions:

- What is the current status of human ecology?
- What are our common visions of collaboration for human ecology?
- What steps can take us from where we now are to where we want to be?

Alternating small-group workshops and plenary sessions will address each of these questions in turn. On the first day, following an opening general session, we will break into small working groups to consider the current status of human ecology. The working groups will come back together at the end of the day to synthesize their work in a plenary session. The same process will be repeated on Days 2 and 3, working with our visions of collaboration and steps to achieve collaboration. Conceptually, the process flows as follows:

Professional Facilitation: We have engaged the services of Interaction Associates, a professional facilitation firm, to help design and coordinate the conference. A Senior Associate of the firm is working with us both throughout the planning process and during the conference itself. Professional facilitators will work with each small group.

Small Group Sessions: Participants will be assigned to one of eight small working groups by conference coordinators. A good mix of perspectives will be assured in each group. The groups will be kept small (maximum fifteen) to assure that everyone has an opportunity to contribute. Each time we break into small groups, a the mix of individuals will be different.

Facilitators will keep the flow of dialogue moving forward; trained recorders will track major points as they emerge, taping them on the walls to keep them before the group. Each group will elect a spokesperson or rapporteur to report back to the plenary session.

Plenary Sessions: After each round of small group sessions, the conference will meet in plenary session to hear the reports of the working groups. After reporting back, the rapporteurs will form a panel and, working with a facilitator, will seek synthesis among their group's statements and recommendations. The plenary session will then be opened to comments from the floor.

Comment and Synthesis: Four individuals have been invited to address the conference as a whole. They will comment on the results of the small group and plenary sessions and seek synthesis along the three main lines laid out above (status of human ecology, visions of collaboration, and steps to collaboration). They are: **Dr. Raymond Dasmann**, University of California at Santa Cruz; **Dr. Susan Lees**, Cleveland State University; **Dr. Ulrich Loening**, Director, Centre for Human Ecology, University of Edinburgh, Scotland; and **Dr. Joseph Meeker**, Fellow, Institute for Human Ecology.

Adopting Recommendations: Immediately following the third plenary session, a conference-ending general session will be convened. This session will hear and approve final consensus statements prepared by the panels of rapporteurs on the current status of human ecology and visions for collaboration. Ratification will be sought on each recommendation made by the final panel of rapporteurs.

Published Proceedings: The adopted conference recommendations will serve as an introductory section to a published volume, tentatively entitled *Human Ecology and Decision-Making: An International and Interdisciplinary Collaboration*.

Invited Papers: Following the conference, papers will be received from those who have submitted abstracts and participated in the entire process. Abstracts will continue to be accepted until 15 November 1988. Papers are to be prepared *after* the conference so that they reflect the experience of participation. They will be organized and published as a three-part volume, reflecting the integrating questions of the conference.

Luncheon Speakers: The conference will also be addressed by luncheon speakers. On Friday, **Donald B. Straus**, Past President of the American Arbitration Association, will speak on "Human Ecology and Decision-Making." **John Garcia**, Principal of BioSystems Analysis, Inc. will speak on "Chaos and Modeling" on Saturday.
